Minutes of the 2022 Annual General Meeting

January 30, 2023 Electronic Meeting held using Zoom.

1.0 Presentation of Credentials

The meeting was called to order at 7:04 pm with Tim Baigent, President welcoming the delegates to the Annual General Meeting and introduced the Board of Directors. Tim explained the committees the club has and invited members to join a committee if they wish. Dawn Dinsdale, General Manager explained the electronic meeting procedures including specifics for voting.

2.0 Roll Call

The General Manager, Dawn Dinsdale, performed the Roll Call, identifying clubs eligible to vote and total number of votes per club. Only clubs who participated in the previous outdoor season (2022) or had their submitted club applications approved by the OASC Board of Directors are eligible to vote. Votes per club are based on the number of teams registered by a club in the previous outdoor season. Dawn Dinsdale confirmed quorum was reached for all voting divisions.

3.0 Amendments to the Constitution

Tim Baigent, President explained the heritage of the current Constitution and the Board's effort to modernize some of the language that was no longer important. Through a review process with the Board and legal counsel, amendments to the Constitution were developed for this AGM's consideration.

Move by CSMA and second by GDMS to amend the constitution

Amendment #1 – change the number of officers to be 4 officers of the corporation: President, Vice President, Secretary and Treasurer. All remaining board members would be Directors at Large.

Amendment #2 – Remove section 9 and 10 as only needed when first incorporated

Amendment #3 – Update section 11 which updates to Directors at Large

Amendment #4 – Section 13 removed on the advice of legal council

Amendment #5 – Section 14, 14.3 and 14. 7 remove the requirement to have the director must reside in reasonable proximity and if a director becomes bankrupt

Amendment #6 – Section 18 voting process change and make all directors equal.

Amendment #7 Section 23 removal of the Officers being compensated

Amendment #8 Section 27, 27.3, 27.4, 27.5 and 27.6 the removal of debentures as not interested in this.

Amendment #9 Section 31 Removal of Directors at Large as Officers of the Corporation

Amendment #10 – Section 32 Removal of Directors at Large as Officers of the Corporation

Amendment #11 – Section 33 Removal of Directors at Large as Officers of the Corporation

President's Report



The Ottawa Adult Soccer Club has emerged well from the challenges of the pandemic. We are in excellent financial shape and the club is well supported by Dawn Dinsdale, Steve Kovacic and the Board of Directors.

We are also fortunate to have a very dedicated community of team managers who pitch in every week to ensure that their team is contributing in a positive way for our club.

We should all be proud of our club and what we achieve each year for our community.

Team entries were up for the fourth year in a row and I am optimistic that we have turned the corner with regard to team retention and growth. Player registration increased to 1199 which was an increase of 25% from 2022.



5 of our teams participated in the Ottawa Carleton Soccer League with all performing well and with an excellent discipline record. The OCSL continues to run a good league but they were hit hard in the pandemic and their financial recovery is taking longer than we expect.

Financially the EODSA has recovered from the pandemic and our district is in good financial health. During the last year the EODSA has modernized the constitution to be compliant with provincial legislation.

League Report

The OASC had a very successful season operating the following divisions:

- 4 divisions of Men (11 v 11)
- 1 division of Men Over 35 (7 v 7)
- 2 divisions of Women (7 v 7)
- 2 divisions of Women over 45 (7 v 7)

The season we had 63 teams join the OASC. This included 58 teams playing within our own league and 5 teams playing in the OCSL under the OASC banner.

The men's 11 v 11 divisions saw very competitive finals in both the Challenge Cup and Presidents Cup. For the Challenge Cup we had the Division 2 champions Warren FC meet up against the Division 1 champions GDMS Gunners. The game was very close until midway through the 2^{nd} half with the Gunners victorious with a score of 3-1. With the win the GDMS Gunners won the league and cup double for the 2^{nd} year in a row.

The Presidents Cup had 2 very strong teams. Lynwood Lightning and newcomers Bird Squad FC facing off. With no scoring throughout regulation and extra time the game went to penalty kicks with the Lynwood Lightning finally sealing the win.

Match Official Report

The 2023 season continued to have many challenges on the match official front. There were many youth games throughout the EODSA missing match officials. The shortage of match officials in our district will continue for the foreseeable future.

I recently attended a District Club Head Referee meeting. Our District Referee Coordinator, David Smith showed the statistics on referee recruitment. There is minimal growth in adult referee recruitment. For the youth referees, there is significant growth, however, each year, more than 50% of youth referees do not return to the field.

Reasons for match officials not returning to the field are, education commitments, employment opportunities, moving out of our District, cannot commit time, and receiving verbal abuse and at times, physical abuse. Fortunately, there has not been any reports of match official abuse in our club. The OASC will not tolerate abuse of any kind towards match officials.

For the 2023 OASC season, we had 252 11 v 11 games and 199 7 v 7 games. The EODSA assigned referees to all 451 games and we had no games where the referee did not attend.

We had 15 games postponed, mainly due to inclement weather.

If any members are interested in becoming a match official, please contact me. New match officials are required to take an online course administered by Ontario Soccer, pass an online exam, and attend an on field practical session with instructors.

Discipline Report

The 2023 season was good from a discipline standpoint. I would like to thank you all for the continued success. There were more teams in the league which resulted in more games and slightly higher dismissal and caution rates. The suspensions and games suspended were higher as we dealt with some challenging players early in the season. After an investigation these players were asked to attend a discipline by hearing and were suspended as well as fined. There are a few players who have not paid their outstanding fines so they will be suspended until they are in good standing with the OASC which also increased the games suspended total.

There is still room for improvement to demonstrate respect for the teammates, opponents, and match officials.

We plan to improve in this area with several corrective actions with teams that are displaying unacceptable discipline indexes. The corrective actions will range from a team being placed on probation, performance bonds to expulsion from our league. These corrective measures are in place to maintain the leagues standard for a competitive, fun, and friendly environment in which to play soccer. There will be 8 teams on a discipline performance bond in 2024. These teams will be notified by the OASC.

Finally, I would like to thank the 2023 Discipline Panel Members: Peter Judd, Dawn Dinsdale, and Kevin Crothers. These people are invaluable to maintaining an efficient discipline process within the guidelines of the EODSA and ensuring that our member costs are kept down. All panel members were re-certified by Ontario Soccer in 2023.

OCSL Report By Mike Moran

Summary

- Five teams participated in OCSL divisions in 2023. •
- Men OT and Masters divisions were restructured in 2023 to have smaller number of teams with home and away games against all other teams in division.
- Our OCSL committee was formed and started meeting in fall of 2023.
- OCSL constitution and rules reviewed in December.
- Attended 2023 OCSL AGM on January 13, 2024. Most of our proposed constitution and rule changes were passed.

OCSL teams, summaries and comments

Men Rec 6 – OCSL combined MR5 and MR6 divisions for 2023. This created schedule anomalies with some weeks having Mon + Wed games then no game following week. Spitfires finished in 7th place of 10 teams.

Men OT2 – Successful season for first year participating in OT2. Managed to finish 3rd in 11 team division. Not happy that division was merged with OT1 during mid-season.

Men OT3 – Finished second in 8 team division. Good season but some challenges with attendance on Fridays. Some far away games (Perth, Russell).

Men OT7 – Promoted to higher division in 2023. Finished fourth in 8 team division.

Masters OT3 – First year for Masters team. Finished 6th in 8 team division. Challenges with finding spares in mid-season.

OCSL AGM notes and 2024 changes

- OASC proposed two constitutional amendments (both passed) and two bylaw changes (1 passed). OASC also motioned for OCSL to comply with ONCA requirements prior to deadline of Oct 2024.
- OCSL has financial problems. OCSL wrote off \$17k of bad debt when a club ceased operations in the middle of the season. Cash reserves are very small considering the size of the operation. The OCSL has not provided a detailed plan on how to improve their financial position over coming years.

Recreational team fees have increased by \$25 per team (now \$525). Field fees have increased by \$100 (fees vary by grass, lighted, turf). Referee fees for the OCSL games will increase \$20 per game in 2024 but these are set by Ontario Soccer.

Marketing Report

Marketing the club remains a challenge although we did make some improvements.

Our Early Bird promotion was a big success with 44 of our teams participating. Having teams register early makes a big difference in planning the season so we hope many of you will participate again in 2024.

Our partnership with Atletico Ottawa was again strong and many team managers took advantage of the partnership by watching a game from a suite or from the club seats during the season. We plan on repeating this program in 2024.

Our partnership program has grown to include discount ticket sales in entertainment as well as sports and we expect to continue to grow this in 2024. If you have a suggestion for a new partner, please let Dawn or myself know.

We were hoping to film a lot of games last year but our inability to find a summer student for this job meant that we only managed to film 8 games in the last few weeks of the season. A different approach will be taken in 2024 when we plan on outsourcing this work to a contractor rather than a summer student.

Our social media remains patchy and a better focus is needed in this area.

We have recently started an email newsletter "On the Ball" and we hope to issue a new newsletter every month.

I would like to thank Dawn Dinsdale and Stewart Wilkinson for assisting in our Marketing work for 2023. However, we could do with some more marketing expertise to promote the club. If you have these skills and would be willing to advise or assist us it would be appreciated.

City of Ottawa Partnership Report By Tim Baigent

Phase 1 of our partnership with the City of Ottawa will end in 2024 as we will exhaust our prepaid contribution to the Richcraft field.

In phase 2 of our agreement we will continue to have priority usage of the field but permits will now need to be paid for which will result in higher team fees in 2025.

Some preliminary discussions have taken place with the City over a field replacement. The City expects that the existing field has another 5 years of useful life before it needs to be replaced.

Finance Report

By Derek DiNardo

The club continues to be in good financial shape.

Our financial position as at September 30, 2023 (year-end) was strong, showing assets in excess of our liabilities. During 2023 we moved our excess cash into a GIC to take advantage of the higher interest rates, but also remaining conservative with the cash balance.

Subsequent to year end, in January 2024, we paid down the CEBA loan of \$40,000, which allowed us to finalize taking advantage of the government's program to forgive \$20,000 of the original \$60,000 loan.

The OASC currently has no outstanding debt, further supporting our financial health.

In 2023 the league generated a surplus of revenues over expenses of \$16,000. Despite using some of our surplus to subsidize fees for the 2023 season, we were able to recuperate this cost through selling more field permits for the Richcraft field than we expected. An increase in the number of teams further supported revenue growth.

In 2023 we also saw a significant increase in referee fees. This was to be expected given the mandated increase to these fees. The increase in number of teams also saw our expenses increase across the board, including in field rentals.

Looking forward, we continue to be mindful of the potential costs associated with refurbishing the turf at Richcraft, as it nears the end of its 10-year useful life.

- 1. To be eligible for the Early Bird Special promotion teams must submit an application form and \$250 deposit by February 28th 2024 and the balance of their league fees by April 15th 2024.
