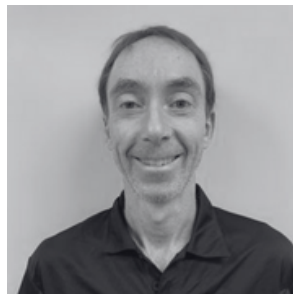

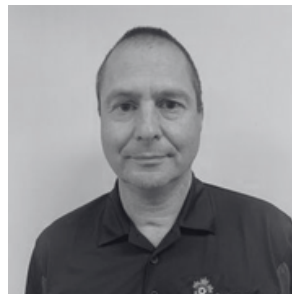

February 5th, 2024

Dawn Dinsdale confirmed quorum was reached for all voting divisions.

President's Report

In 2019 we faced an uncertain future when we were only able to field 39 teams. Since then we have rebranded our club and refocused our business plan to address the changing Ottawa soccer market. We saw the success of that effort in 2024 when we put 78 teams on the field, a 100% increase in just 5 years.

The lynch pin of our success is our 2014 agreement with the City of Ottawa that allows us access to the Richcraft turf field. The first phase of that agreement is now complete as we have exhausted our free field permits in lieu of our capital contribution. Our agreement allows us to continue to use the field until it needs to be replaced, however, all future Richcraft permits will have to be purchased meaning that our team entry fees will see a significant price increase in 2025.

The 2014 agreement also offers the club the opportunity to renew its partnership with the City on a replacement field at Richcraft. It is currently our intention to exercise that benefit at the appropriate time and we have informed the City of this decision. In addition, we are now investigating in earnest the possibility of developing a 2nd turf field. Our preference would be to again partner with the City on this project however we will consider other options.

In 2024, 63 teams participated in our own league. 34 men's teams participated in 4 divisions of 11 v 11 and all divisions were competitive. We also had 2 outstanding cup competitions. This resulted in our best 11 v 11 season for many years.

Our 7 v 7 divisions were again very popular with the women divisions being oversubscribed. We don't want to turn any team away but we do need to address the scheduling issues for our women's divisions. Consequently, we have identified the need for a new committee to focus on issues with our Women's program. Dawn Dinsdale will chair that committee but we are looking for 4 others to join.

In the OCSL we fielded 15 teams after the successful merger with Lynwood Centennials SC. All 15 teams represented the club well with 3 championships won by the Legends (OT3), Spitfires (OT7) and the Glens (Masters 3). We also hosted an 8 team tournament for Old Timers teams in September with Lynwood OT3 winning the tournament. Thank you to Kevin Judd for organizing the event.

In 2024, we chose the Kanata Food Cupboard as our charity partner. Our financial donation was greatly received by their executive director. We hope to announce our 2025 charity partner in the Spring.

Finally, a big thank you to the 12 individuals who form our dedicated Board of Directors and staff, and to the 78 team managers who work hard to get their team prepared. I look forward to seeing you again in 2025.

League Report

The club had a very successful season operating the following divisions:

The President's Cup saw AC Minority and Antonys Fidget Spinner facing off. Antonys sealed the win with a final score of 3-1. Both games, along with a suite of regular league games can be viewed on our YouTube channel.

Match Official Report

The 2024 season was a very busy one for match officials.

The number of match officials in our district, is still below our pre-pandemic numbers. As mentioned in my report last year, the shortage of match officials in our district will continue for the foreseeable future. If any members are interested in becoming a match official, please contact me, and I can advise you on how to get started.

Recruitment of match officials is very much like taking “two steps forward and then three steps backwards”. The district with the assistance from the major youth soccer clubs, recruits new match officials. New match official recruits are required to do an online course, attend an on field practical session with instructors, and obtain 80% or higher in the exam. On the downside (three steps backwards), we lose many match officials who simply do not return for various reasons.

I am pleased to say, there were no reports in 2024, of match official physical or verbal abuse in our club. The OASC will not tolerate abuse of any kind towards match officials.

Here are some statistics from the OASC 2024 season:

1. There were 486 games scheduled.
2. 44 referees were assigned to OASC games.
3. 15 of those referees officiated 10 or more games for us.
4. All referees attended their game, no games were cancelled because of a referee no show.
5. All OASC games are assigned referees by the EODSA.

Finally, I received 3 match official complaints in 2024. Two complaints were from the 7v7 division and one from an 11v11 division. Complaints consisted of the referee was not paying attention to the game and not clamping down on aggressive play, a referee showed a lack of control of the game, bad positioning, non-safe environment for players, and a referee gave out unfair cautions and decisions.

Discipline Report

The 2024 season was more challenging from a discipline standpoint. I would like to thank you all for continuing to strive to keep our league both fun and competitive. The continued growth of teams in the league resulted in more games and slightly higher dismissal and caution rates. The suspensions and games suspended were higher as we dealt with some challenging players and teams throughout the season. After each investigation these players were asked to improve their style of play or have their team be placed on a mid-year discipline performance bond.

There is still room for improvement to demonstrate respect for the teammates, opponents, and match officials.

We plan to improve in this area with several corrective actions with teams that are displaying unacceptable discipline indexes. The corrective actions will range from a team being placed on probation, performance bonds to expulsion from our league. These corrective measures are in place to maintain the leagues standard for a competitive, fun, and friendly environment in which to play soccer. There will be 7 teams on a discipline performance bond in 2025 and the discipline index was set to 0.90 for the upcoming season. These teams have been notified by the OASC. Please remember it is a privilege to play in the league, not a right.

Finally, I would like to thank the 2024 Discipline Panel Members: Peter Judd, Dawn Dinsdale, and Kevin Crothers. These people are invaluable to maintaining an efficient discipline process within the guidelines of the EODSA and ensuring that our member costs are kept down. All panel members were re-certified by Ontario Soccer in 2024. We are looking for help on some as our membership continues to grow both in the OASC and OCSL leagues. Marketing Report

The club continues to make progress with its marketing program.

Atletico Ottawa partnership

We renewed our partnership with Atletico Ottawa with the purchase of over 600 tickets for a match against Forge FC in May. These tickets were distributed to the 78 team managers. In return for the purchase Atletico gave us 10 free season tickets in the Club section and 3 suites. These tickets were subsequently offered to team managers as a thank you for their dedication.

For 2025 we intend to repeat the partnership but we will try to spread out the purchased tickets over several games rather than just one.

Ottawa Rapids FC are our new professional women's team. They will start their first season in the Northern Super League in April 2025. The women's committee will be consulted to see if there is interest in creating a similar partnership with them.

Match videos

We managed to film 32 games in 2024. All games are available on our YouTube channel with 5 minute highlights also available on our website homepage. We plan on repeating the program in 2025.

On The Ball Newsletter

We started an email newsletter in 2024. On The Ball will continue to be our main method of communicating with members via email.

Social Media

We only used X in 2024 for social media posts. X will continue to be our main platform for social media but we hope to occasionally post on Facebook and Instagram in 2025.

Ticket partnerships

Our partnerships with the Ottawa Senators and Broadway Across Canada continue to be popular. Both programs offer significant savings on tickets. Last year members saved over \$5000 on their Senators tickets through our program.

Contractors

I would like to thank Olivia McEwen and Bailey Irving for their work with our marketing program in 2024. Both brought their expertise and dedication to improve our clubs image. However, you can never have too much expertise in marketing so if you have skills in marketing that could help the club, please let us know.

Finance Report

The club continues to be in good financial shape.

Our financial position as at September 30, 2024 (year-end) was strong, showing assets in excess of our liabilities. On our balance sheet, the major change for the year was that this was the final year of amortization of the Richcraft field. Since our participation with the City back in 2014 on the construction of Richcraft, we have carried our upfront payment as a prepaid asset, and began to amortize this into expenses over 10 years. This asset wound up at the start of the 2024 season.

At year-end we had a material balance of \$89,000 in accounts receivable. The majority of this balance has been collected in October to December 2024, and the current outstanding balance is around \$1,000. The majority of this balance was related to timing of transitioning cash through our merger with Lynwood.

The OASC currently has no outstanding debt, further supporting our financial health.

In 2024 the league had an excess of expenses over revenues of \$55,700. The main driver of this unfavorable result was \$42,167 relating to amortization of the Richcraft field as previously mentioned, coupled with the fact we also were charged by the City of Ottawa in the year for Richcraft. This results in a double hit of Richcraft for the 2024 fiscal year.

Outside of this unique situation with the Richcraft field, we had a steady year. The number of teams in the OASC was up resulting in higher revenues and expenses. We piloted a few new programs in 2024, including a service that allowed us to post highlight videos of matches online. There were no other material expense or revenue variances of note during the year.

As mentioned at our previous general meeting, the sunset of the Richcraft deal with the City of Ottawa will likely result in an increase to member fees in 2025. We are continuing to negotiate with the City to ensure that the OASC maintains our privileged access to the field.

Resolution:

Whereas the audited financial statements of the Corporation ending September 30, 2024 have been described to the Members and certain highlights thereof presented to the Members, such financial statements are approved.

Appointment of Auditors

The Board of Directors are proposing Parker Prins Lebano be reappointed as our auditors for 2025.

Resolution:

Whereas the Corporation is required to have financial statements audited in each fiscal year, the firm of Parker Prins Lebano is hereby appointed to be auditors for the fiscal year 2025.

Unfinished Business

There was no unfinished business from the last AGM.

Amendments to the Constitution and Competition Rules

No amendments have been proposed.

All positions are for a term of 2 years.

Starting with position 1, the Vice President.

Any person over the age of 18 and who is not presently declared a bankrupt may be nominated for any position.

When there is only one person nominated for a position then that person shall be acclaimed. When multiple people are nominated for a position then a vote of the members by secret ballot will determine who is elected. The person receiving the most votes will be declared the winner of the election.

A person who is defeated in an election may subsequently be nominated for any of the remaining positions.

Nominees for any Director position may be made from the floor. In advance of the meeting the following people have nominated themselves for a position on the Board of Directors.
