Match Official Report

I am pleased to report, that the Match Official pool in the Eastern Ontario Soccer district (EOS), has recovered well since the pandemic. The pandemic had a major effect on the Match Official pool, and our district had a huge decline in registrations. Each year since the pandemic, the numbers in our district have been slowly recovering. The Eastern Ontario Soccer district, has now recovered to exceed pre-pandemic numbers and our district now have the most match officials in Ontario.

However, Match Official recruitment is always required. If you are interested in becoming a Match Official, please contact me and I can assist in the process to apply.

For the 2025 season, we used 45 Match Officials for 454 games. There were 17 Match Officials who officiated more than 10 games for the OASC.

We had one Match Official complaint, which was escalated to the District for a hearing.

I did receive a few comments concerning Match Officials at OASC games, the reasons are listed below:

- Concerns on a Match Official's quality/experience for a game.
- Concerns over a Match Official's handling of a game involving racial/insulting language, mass confrontation and violent conduct.
- A Match Official not wearing the appropriate uniform required.
- A Match Official not checking ID cards correctly.
- A Match Official unaware of the card checking policy.

In each case, I communicated with the Match Official to hear their response to the comments, and advise if required.

There are some new law changes for the 2026 season. The biggest change will be that goalkeepers will only be able to hold onto the ball for 8 seconds. If they exceed that then the referee will award a corner kick to the opponents. I will try to obtain some education material on the new laws so I can post it on our website.

Discipline Report

The 2025 season was a challenging year from a discipline standpoint. I would like to thank you all for continuing to strive to keep our league both fun and competitive. The competition in the league resulted in slightly higher dismissal and caution rates. The suspensions and games suspended were lower but the number of cautions increased with fewer number of games being played. Throughout the year we had several challenging events and after each investigation these players were asked to improve their style of play or have their team be placed on a mid-year discipline performance bond.

There is still room for improvement to demonstrate respect for the teammates, opponents, and match officials.

We plan to improve in this area with several corrective actions with teams that are displaying unacceptable discipline indexes. The corrective actions will range from a team being placed on probation, performance bonds to expulsion from our league. These corrective measures are in place to maintain the leagues standard for a competitive, fun, and friendly environment in which to play soccer. There will be 9 teams on a discipline performance bond in 2025 and the discipline index was set to 1.00 for the upcoming season. These teams have been notified by the OASC. After an analysis of the discipline index we have modernized the calculation due to the fact that the overall game has modernized and game officials are expected to give out automatic cautions. The new caution rate in the discipline index has been reduced to 0.75 and the dismissal rate has remained the same. Please remember it is a privilege to play in the league, not a right.

Finally, I would like to thank the 2025 Discipline Panel Members: Peter Judd, Dawn Dinsdale, and Kevin Crothers. These people are invaluable to maintaining an efficient discipline process within the guidelines of the EODSA and ensuring that our member costs are kept down. All panel members were re-certified by Ontario Soccer in 2024. We are looking for help on some as our membership continues to grow both in the OASC and OCSL leagues. Please contact any board or director if you are interested in discipline and obtaining a discipline certification from Ontario Soccer.

Finance Report

The club continues to be in good financial shape.

Our financial position as at September 30, 2025 (year-end) was strong, showing assets in excess of our liabilities. Our cash position has increased by \$78,000, and we were able to add \$150,000 to our GIC during the year. Our strong cash position is a result of two items:

1. We have not paid the City of Ottawa for two years for Richcraft. We are currently in discussions with them surrounding their billing and a contract we had with them that we expect them to honour. However, to be conservative we have also recorded this balance in accounts payable. If we are unsuccessful in our negotiation, we will need the full \$150,000 added to the GIC to settle the balance due to the City.
2. In 2024 we had a significant accounts receivable balance, which we have collected.

The OASC currently has no outstanding debt, further supporting our financial health. Our uniform reserve sits at \$25,000. We encourage teams to leverage this feature of the OASC.

In 2025 the league had an excess of revenues over expenses of \$50,000. This is a result of more field rentals compared to what we budgeted and at a higher rate to third parties of the Richcraft field in the year, which is a great alternative revenue stream for the league.

From our operations of running the league, we continue to operate closer to break-even, which is our target when we set our league fees annually.

We continue to negotiate with the City of Ottawa on the Richcraft field to ensure we can continue to receive preferable rates. We also continue to explore new opportunities for adding another field to our rotation similar to Richcraft.

Resolution:

Whereas the audited financial statements of the Corporation ending September 30, 2025 have been described to the Members and certain highlights thereof presented to the Members, such financial statements are approved.

Appointment of Auditors

The Board of Directors are proposing Parker Prins Lebano be reappointed as our auditors for 2026.

Resolution: Whereas the Corporation is required to have financial statements audited in each fiscal year, the firm of Parker Prins Lebano is hereby appointed to be auditors for the fiscal year 2026.

Unfinished Business

There was no unfinished business from the last AGM.

Amendments to the Constitution and Competition Rules

No amendments have been proposed.

Election of Officers

The following Director positions are open for election:

1. President
2. Treasurer
3. Director at Large (Referees)
4. Director at Large 1
5. Director at Large 2

All positions are for a term of 2 years.

Starting with position 1, the President.

Any person over the age of 18 and who is not presently declared a bankrupt may be nominated for any position.

When there is only one person nominated for a position then that person shall be acclaimed. When multiple people are nominated for a position then a vote of the members by secret ballot will determine who is elected. The person receiving the most votes will be declared the winner of the election.

A person who is defeated in an election may subsequently be nominated for any of the remaining positions.

Nominees for any Director position may be made from the floor. In advance of the meeting the following people have nominated themselves for a position on the Board of Directors.
